This Indenture, Made this 10th day of May, 1984,

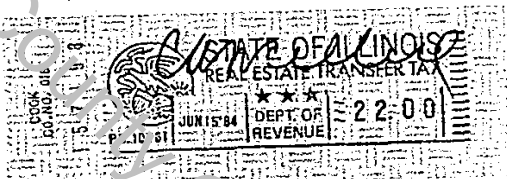
