THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE I (THE REVERSE SIDE OF THIS TRUST DEED):

1. Mortgagors shall (a) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (b) keep said premises in good condition and repair, without waste, and free mechanic's or their liers or claims for lien not expresdy subordinated to the lien hereof, (c) pay when due any indebtedness which may be secured by a lien or charge on holders of the note; (d) complete within a reasonable time any building or buildings now or at any time in process of receion upon said premises; (6) comply with all requirements of low or maniferal ordinates with respect to the premises and the use thereof; (0) make no the premises, and the repair of the premises which the premises and the use thereof; (1) make no express the premises, and other charges against the premises when due, and shall, upon written request, furnish to Trustee or to holders of the note duplicate receipts therefor. To prevent default hereunder Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagors may desire to contest.

3. The proceeds of any foreclosure sale of the premises 3\*\* (\*\*) distributed and applied in the following order of priority: First, on account of all costs and expenses incident to the foreclosure proceeds (\*\*) including all such tients as are mercioned in the preceding paragraph hereof; second, all other items which under the terms hereof constitut, e secure (\*\*) debtedness additional to that evidenced by the note, with interest thereon as herein provided; thind, all principal and interest remainin unpai, on the note; fourth, any overplus to Mortgagors, their heirs, legal representatives or assigns, as their rights may appear.

9. Upon, or at any time after the filing of a bill to foreclose the trust deed, the court in which such bill is filed may appoint a receiver of said premises, Such appointment may be made either before or afte, al., w, bout notice, without regard to the solvency or insolvency of Mortgagors at the time of application for such receiver and without regar to t.\* then value of the premises of a said premise shall be then occupied as a homestead or not and the Trustee hereunder may be appoint "as ach receiver. Such receiver shall have power to collect the rents, issues and profits of said premises during the pendency of such foreclose; suit and, in each of said engines, except for the intervention of such receiver, would be entitled to collect such rents, issues and profits of powers which may be necessary or are usual in such cases for the protection, possession, control, management and operation of the promises during the whole or in part of: (a) The indebtedness secured bytes, or by any decree foreclosing this trust de

This Trust Deed and all provisions hereof, shall extend to and be binding upon Mortgagors and all persons claiming under or through Mortgagors, and the word "Mortgagors" when used herein shall include all such persons shall all persons liable for the payment of the indebtedness or any part thereof, whether or not such persons shall have executed the note or this Trust Deed. The word "note" when used in this instrument shall be constructed to mean "notes" when more than one note is used.

16. Before releasing this trust deed, Trustee or successor shall be entitled to reasonable compensation for any other act or service performed under any provisions of this trust deed. The provisions of the "Trust And Trustees Act" of the State of Illinois shall be applicable to this trust deed.
