Bartlett's Chicago Highlands in the North East 1/4 of the North East 1/4 of Section 19, Township 38 North, Range 13, East of the Third Principal Meridian, in Cook County, Illinois, which survey is attached as Exhibit "D" to the Declaration of Condominium recorded as Document No. 26332270, as amended from time to time, together with its undivided percentage interest in the common elements, in Cook County, Illinois.

Party of the first part also hereby grants to parties of the second part, their successors and assigns, as rights and easements appurtenant to the above described real estate, the rights and easements for the benefit of said property set forth in the aforementioned Declaration, and party of the first part reserves to itself, its successors and assigns, the rights and easements set forth in said Declaration for the benefit of the remaining property described therein.

This Deed is subject to all rights, easements, restrictions, conditions, covenants, and reservations contained in said Declaration the same as though the provisions of said Declaration were recited and stipulated at length herein.

This Deed is conveyed on the conditional limitation that the percentage of ownership of said Grantees in common elements shall be divested pro tanto and vest in the Grantees of the other units in accordance with the terms of said declaration and any amended Declarations recorded pursuant thereto. And the right of revocation also hereby reserved to the Grantor herein to accomplish this result. The Acceptance of this conveyance by the Grantees shall be deemed an Agreement with the Contemplation of the Condominium property Act of the State of Illinois to the shifting of the common elements pursuant to said Declaration and to all other terms of said Declaration. Which is hereby incorporated herein by reference thereto to all the terms of each Amended Declaration recorded pursuant thereto together with the tenements and appurtenances thereunto belonging.

TO HAVE AND TO HOLD the same unto said party of the second part, and to the proper use, benefit and behoof forever of said party of the second part.

Subject to: General taxes for the year 1983 and subsequent years and to covenants, restrictions and easements of record.
