


LEGAL DESCRIPTION FOR DEED

PARCEL 1: UNIT NO. 20-BB-2, as delineated on the survey of the following described real estate (hereinafter referred to as "Parcel"):

That part of Lot 3 in Cross Creek, being a subdivision of the Northwest ¼ of the Southeast ¼ of Section 35, Township 41 North, Range 10, East of the 3rd P.M., according to the plat thereof recorded February 7, 1979 as document 24835738 bounded by a line described as follows: Beginning at a point 602.89 ft. North as measured along the East line thereof, and 29.86 ft. West, as measured at right angles to said East line, of the Southeast corner of said lot 3; thence South 64 degrees 30 minutes 00 seconds West, 11.23 ft.; thence North 25 degrees 30 minutes 00 seconds West, 152.42 ft.; thence North 64 degrees 30 minutes 00 seconds East, 70.73 ft.; thence South 25 degrees 30 minutes 00 seconds East, 152.42 ft. to the place of beginning. Grantor also hereby grants to Grantee, their successors and assigns, as rights and easements appurtenant to the above described real estate, the rights and easements for the benefit of said property set forth in the aforementioned Declaration of Condominium Ownership and hereby reserves to itself, its successors and assigns, the rights and easements set forth therein for the benefit of the remaining property described therein.

PARCEL 2: Grantor also hereby grants to Grantee, their successors and assigns, as rights and easements appurtenant to the above-described real estate, the rights and easements for the benefit of said property set forth in the Declaration of Covenants, Conditions, Restrictions and Easements for the Cross Creek Homeowners' Association dated the 1st day of September, 1979, and recorded in the Office of the Recorder of Deeds, Cook County, Illinois, as Document No. 25155624, which is incorporated herein by reference thereto. Grantor reserves to itself, its successors and assigns, as easements appurtenant to the remaining property described in said Declaration, the easements thereby created for the benefit of said remaining property and this conveyance is subject to the said easements and the rights of the Grantor to grant said easements in the conveyance and mortgages of said remaining property or any of them.
