DEED LEGAL

PART OF LOT 1 AND ACCRETIONS THERETO OF LAKE FRONT ADDITION, BEING A SUBDIVISION OF STOLOT 1 (EXCEPT THE SOUTH 33 FEET THEREOF) OF THE CASSESSOR'S SUBDIVISION OF THE CASSESSOR'S SUBDIVIS

GRANTOR ALSO HEREBY GRANTS TO GRANTEE, THEIR SUCCESSORS AND ASSIGNS, AS RIGHTS AND EASEMENTS APPURTENANT TO THE ABOVE DESCRIBED FEAL ESTATE, THE RIGHTS AND EASEMENTS FOR THE BENEFIT OF SAID PROPERTY SET FORTY.
