Trustee shall release this Trust Deed and the lien thereof by proper instrument upon presentation of satisfactory evilence; that all indebtedness secured by this Trust Deed has been fully paid; and Trustee may execute and deliver a release hereof to and at the leavest of any person who shall either before or after maturity thereof, produce and exhibit to Trustee the principal note, representing that all indebtedness secured has been paid, which representation Trustee may accept as true without inquiry.
