AS HEREBY GRANTS TO PARTIES OF THE SECOND PART, THEIR SUCCESSORS A 1D ASSIGNS, AS RIGHTS AND EASEMENTS APPURTENANT TO THE ABOVE DESCRIBED REAL ESTATE, THE RIGHTS AND EASEMENTS FOR THE BENEFIT OF SAID PROFERTY SET FORTH IN THE AFOREMENTIONED DECLARATION, AND PARTY OF THE FRIST PART RESERVES TO ITSELF, ITS SUCCESSORS AND ASSIGNS, THE RIGHTS AND EASEMENTS SET FORTH IN SAID DECLARATION FOR THE BENEFIT OF THE REMAINING PROPERTY DESCRIBED THERE-IN.

ND SUBSEQUENT YEARS, The Act, Declaration and By-Laws, Plat, rights of the public, the State of Illinois and the Municipality in and to that part of land, if any under or used for road purposes, contract for regulation of traffic recorded July 12, 1573 as Document #22397063, roads and highways, applicable zoning and building laws are ordinances, easements, building line and use or occupancy restrictions, covener is and conditions of record.

The Tenant, if any, of the unit conveyed hereby has either waived or has failed to exercise his right of first refusal to purchase said unit or had no such right of first refusal pursuant to the provisions of the Illinois Condominium Property Act and Chapter 5 of he Building Code of the City of Rolling Meadows.
