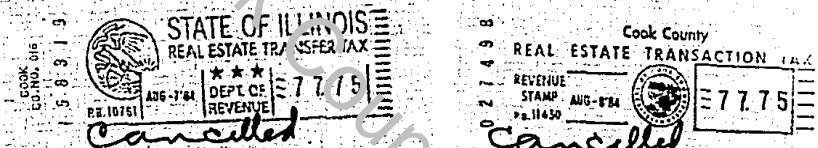


This Indenture, Made this 27 206 660 day of June A. D. 1984
