This Indenture, Made this 9th day of July A. D. 19 84,

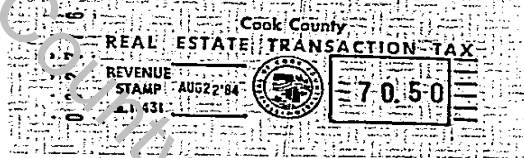

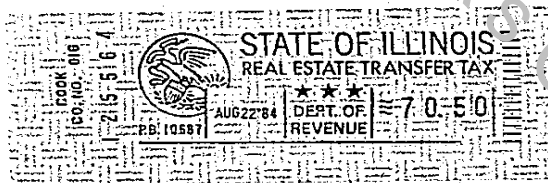
