THE GRANTOR(S): Joel S. Corwin and

for and in consideration of Ten and No/100ths (\$10.00)  
Dollars, and other good and valuable considerations in hand paid,  
Convey and (WARRANT QUIT CLAIMS) unto  
THE FIRST ILLINOIS BANK OF EVANSTON, N.A.,  
ITS SUCCESSOR OR SUCCESSORS, as Trustee under the  
provision of a trust agreement dated the 12th day of  
July, 1984 and known as Trust Number R 3020 (hereinafter referred  
to as "The Trustee") the following described real estate in the County of Cook  
and State of Illinois, to wit:

HEREINAFTER CALLED "THE REAL ESTATE".

TO HAVE AND TO HOLD the real estate with the appurtenances upon the trusts and for the uses and purposes herein and  
the trust agreement set forth.

Full power and authority are hereby granted to the trustee to subdivide and resubdivide the real estate or any part thereof  
to dedicate streets, highways or alleys; to create any subdivision or part thereof; to contract to sell; to grant options to purchase;  
to sell on any terms; to convey either with or without consideration; to convey the real estate or any part thereof to a successor  
successor in trust and to grant to such successor in trust all or the title, estate, powers and authorities vested in the  
trustee; to donate, to dedicate, mortgage or convey a easement the real estate or any part thereof; to lease the real estate, or any  
part thereof, for any term or period of time, to renew or extend leases upon any terms and for any period or periods of time, and for any period or periods of time not exceeding the term of 99 years; and to renew or extend leases  
upon any terms and for any period or periods of time and to amend, change or modify leases and the terms and provisions thereof  
at any time or times hereafter; to contract to make leases and to grant options to lease and options to renew leases and options to  
purchase the whole or any part of the reversion and to contract respecting the manner of fixing the amount of present or future  
rentals; to partition or to exchange the real estate, or any part thereof, for other real or personal property; to grant easements or  
charges of any kind; to release, convey or assign any right, title or interest in or about or easement appurtenant to the real estate or  
any part thereof; and to deal with the real estate and every portion thereof in all other ways and for such other considerations as it would  
be lawful for any person owing the same to deal with the same, whether similar to or different from the ways above specified, at  
any time or times hereafter.

In no case shall any party dealing with the trustee in relation to the real estate, or to whom the real estate or any part thereof  
shall be conveyed, contracted to be sold, leased or mortgaged by the trustee, be obliged to see to the application of any purchase  
money, rent, or money borrowed or advanced on the real estate, or be subject to see that the terms of the trust have been complied  
with, or be obliged to inquire into the title or ownership of any part of the real estate, or be obliged or privileged to inquire into any  
of the terms of the trust agreement and every document, instrument, lease or other conveyance or transfer of any part of the real estate  
to the real estate shall be conclusive evidence in favor of every person relying upon or claiming under any such conveyance, lease or  
other instrument, (a) that at the time of delivery thereof the trust created herein and by the trust agreement was in full force and  
effect; (b) that such conveyance or other instrument was executed in accordance with the trust, conditions and limitations contained  
herein and in the trust agreement or in any amendment thereto and binding upon all beneficiaries thereunder; (c) that the trustee was  
duly authorized and empowered to execute and deliver every such deed, trust deed, lease, mortgage or other instrument; and (d) if the  
conveyance is made to a successor or successors in trust, that such successor or successors in trust have been properly appointed and  
are fully vested with all the title, estate, rights, powers, authorities, duties and obligations of its, his or their predecessor in trust.

The interest of each beneficiary under the trust agreement and of all persons claiming under them or any of them shall be only  
in the possession, earnings, avails and proceeds arising from the mortgage, sale, or other disposition of the real estate, and such interest  
is hereby declared to be personal property, and not beneficiary under the trust agreement, shall have any title or interest, legal or  
equitable, in or to the real estate as such, but only an interest in the possessions, earnings, avails and proceeds thereof as aforesaid.

If the title to any of the above lands is now or hereafter registered, the Register of Titles is hereby directed not to register or  
note in the certificate of title or duplicate thereof, or memorial, the words "in trust," or "upon credit," or "with limitations," or words of similar import, in accordance with the statute in such case made and provided.

And the said grantor(s) hereby expressly waive and release any and all right or benefit under and by virtue of any and all  
statutes of the State of Illinois, providing for the exemption of homesteads from sale on execution or otherwise.
