- 2. Mortgagors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall, upon written request, furnish to Trustee or to holders of the note the original or duplicate receipts therefor. To prevent default hereunder Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagors may desire to contest.
- 3. The Trustee of the holers of the note hereby secured making any payment hereby authorized relating to taxes or assessments, may do so according to any bill, stem at or estimate procured from the appropriate public office without inquity into the accuracy of such bill, statement or estimate or into the vehicle of any tax, assessment, sale, forfeiture, tax lien or title or claim thereof.

- 8. The proceeds of any foreclosure sale of the premises shall be distributed and policy please in the following order of priority: First, on account of all costs and expenses incident to the foreclosure proceedings, including all such treats as the mentioned in the preceding paragraph hereof; second, all other temes which under the terms hereof constitute secured indebtedeness a diffical to that evidenced by the note hereby secured, with interest thereon as herein provided; third, all principal and interest remaining unpaid; that are yet overplus to Mortgagors, their heirs, legal representatives or assigns as their rights may appear.
- 9. Upon or at any time after the filing of a complaint to foreclose this Trust Deed, the Cov. in hich such complaint is filed may appoint a receiver of said premises. Such appointment may be made either before or after sale, without notice without regard to the solvency of Mortgagors at the time of application for such receiver and without regard to the then value of a premises or whether the same shall be then occupied as a hometested or not and the Trustee hereunder may be appointed as such receiver. What power to collect the rents, issues and profits of said premises during the pendency of such foreclosure suit and, in case of a sale and a defic next, during the full statutory period for redemption, whether there be redemption or not, as well as during any further times when Mc tagaors, except for the intervention of such receiver, would be entitled to collect such rents, issues and profits, and all other powers which may be creasary or are usual in such cases for the protection, possession, control, management and operation of the premises during the whole of said perion. This Trust Deed and all provisions hereof, shall extend to and be binding upon Mortgagors and all persons claiming under or through Mortgagors, and the word "Mortgagors" when used herein shall include all such persons and all persons at any time liable for the payment of the indebtedness or any part thereof, whether or not such persons shall have executed the principal pote, or this Trust Deed.
