as Trust No. 51701T, party of the first part, and BERNARD W. McDONNELL, a single person never married,

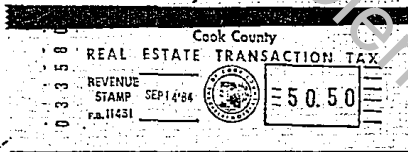
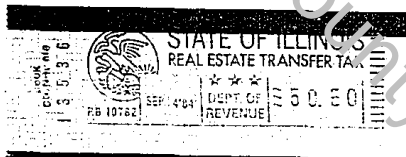
