LEGAL DESCRIPTION FOR DEED

PARCEL 1: UNIT NO. 15-B-2, as delineated on the survey of the following described real estate (hereinafter referred to as "Parcel"):

That part of Lot 3 in Cross Creek, being a subdivision of the Northwest $\frac{1}{4}$ of the Southeast $\frac{1}{4}$ of Section 35, Township 41 North, Range 10, East of the Third P.M., according to the plat thereof recorded February 7, 1979 as document No. 24835738 bounded by a line described as follows: Beginning at a point 462.83 feet East, as measured along the North line thereof, and 34.67 feet South, as measured at right angles to said North line, of the Northwest corner of said Lot 3; thence North 86 degrees 30 minutes 38 seconds East, parallel with the North line of said lot, 152.42 feet; thence South 3 degrees 22 minutes 22 seconds East, 70.33 feet; thence South 86 degrees 30 minutes 38 seconds West, 152.42 feet; thence North 3 degrees 29 minutes 22 seconds West, 70.33 feet to the place of beginning. 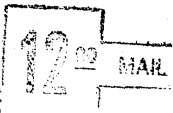
which survey is attached as Exhibit "B" to Declaration of Condominium Ownership and of Easements, Restrictions and Covenants for Cross Creek Condominium Building No. made by First Bank of Oak Park as Trustee under Trust Agreement dated October 2, 1980 and known as Trust No. 12058, and recorded in the Office of the Cook County Recorder of Deeds as Document No. 27446569, together with an undivided 11.38 % interest in said Parcel (excepting from said Parcel all the units thereof as defined and set forth in said Declaration of Condominium Ownership and survey).

Grantor also hereby grants to Grantee, their successors and assigns, as rights and easements appurtenant to the above described real estate, the rights and easements for the benefit of said property set forth in the aforementioned Declaration of Condominium Ownership and hereby reserves to itself, its successors and assigns, the rights and easements set forth therein for the benefit of the remaining property described therein.

PARCEL 2: Grantor also hereby grants to Grantee, their successors and assigns, as rights and easements appurtenant to the above-described real estate, the rights and easements for the benefit of said property set forth in the Declaration of Covenants, Conditions, Restrictions and Easements for the Cross Creek Homeowners' Association dated the 1st day of September, 1979, and recorded in the Office of the Recorder of Deeds, Cook County, Illinois, as Document No. 25155624, which is incorporated herein by reference thereto. Grantor reserves to itself, its successors and assigns, as easements appurtenant to the remaining property described in said Declaration, the easements thereby created for the benefit of said remaining property and this conveyance is subject to the said easements and the rights of the Grantor to grant said easements in the conveyance and mortgages of said remaining property or any of them.
