THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 1 (THE REVERSE SIDE OF THIS TRUST DEED).

1. Mortgagors shall (a promptly epail, restore or r build and buildings or improvement now or hereafter on the premises which may become damaged or be destroyed; (b) teel said primites in sold condition and robat, without waste, and free from mechanic's or other liers or claims for hier not expressly subordinated to the lien hereof; (c) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to holders of the note; (d) complete within a reasonable time any building or buildings now or at any time in process of erection upon said premises; (e) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (f) make no material alterations in said premises except as required by law or municipal ordinance.

2. Mortgagors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall, upon written request, furnish to Trustee or to holders of the note duplicate receipts therefor. To prevent default hereunder Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagors may desire to contest.

2. Mortgages, shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sweet service charges, and other charges against the prennies when due, and shall, upon writine request, furnish to Trustee or to holders of the note of assessment which Mortgagors may desire to contest.

3. Mortgagors shall keep all buildings and migrorements now or bereafter situated on said premises insured against loss or damage by fire, light produced the produced of Mortgagors in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior encumbrances, if any, and purchase, discharge, compromise or settle any tax light produced of the pr

second, all other items which under the terms bereed conditions required indebtedness additional to that evidence by the note, which the foreclosure sale of the premise shall be distributed and applied in the following order of priority: First, on account of all costs and expenses incident to the foreclosure predictions; including all such items as are mentioned in the preceding paragraph hereof; second, all other items which under the terms hereof conditions recurred indebtedness additional to that evidenced by the note, with interest thereon as herein provided; third, all principal and interest relating unpaid on the note; fourth, any overplus to Mortgagors, their heirs, legal representatives or assigns, as their rights may appear.

9. Upon, or at any time after the filing of a bill to forecloss the trust deed, the court in which such bill is filed may appoint a receiver of said premises. Such appointment may be made either before or after sale, without notice, without regard to the solvency or insolvency of Mortgagors at the time of application for such receiver and without regard to the then value of the premises or whether the same shall be then occupied as a homestead or not and the Trustee hereunder may be no obtated as such receiver. Such receiver shall have power to collect the rents, issues and profits of said premises during the pendency of such foreclosure suit and, in case of a sale and a deficiency, during the full standard period of redemption, whether there be tedemption or not, as well as during any further times when Mortgagors, except for the intervention of such receiver, would be entitled to collect such rents, issuer and profits, and all other powers which may be necessary or are usual in such cases for the protection, possession, control, management and worthing any further times when Mortgagors, except for the indebtedness second hereby, or by any decree foreclosing this trust deed, or any to a, special assessment or other lien which may be or become superior to the large levels and addi

10. No act of for the enforcement of the lien or of any provision hereof shall be object to any defense which would not be good and available to the party interposing same in an action at law upon the note hereby secured.

11. Trustee or the holders of the note shall have the right to inspect the premises of all reasonable times and access thereto shall be

Trustee has no duty to examine the title, location, existence or condition of the permises, or to inquire into the validity of the signatures or the identity, capacity, or authority of the signatories on the note or trust deed, nor shall Trustee be obligated to record this trust deed or to exercise any power herein given unless expressly obligated by the terms hereof, nor be liable for any acts or omussions hereunder, except in case of its own gross negligence or misconduct or that of the agents or employees of Trustee, and it may require indemnities satisfactory to it before exercising any power herein given.

13. Trustee shall release this trust deed and the lien thereof by proper instrument upon presentable of a satisfactory evidence that all indebtedness secured by this trust deed has been fully paid; and Trustee may execute and deliver a release for of to and at the request of any person who shall, either before or after maturity thereof, produce and exhibit to Trustee the note, representing, that all indebtedness hereby secured has been paid, which representation Trustee may accept as true without inquiry. Where a release is rocacted of a successor trustee, such successor trustee may accept as the genuine note herein described any note which bears an identification unmore purporting to be placed to the interior by a prior trustee hereunder or which conforms in substance with the description herein contained of the original trustee and it has never placed its identification number on the note described herein, it may accept as the genuine note herein described any note which may be presented and which conforms in substance with the description herein contained of the original trustee and it has never placed its identification number on the note described herein, it may accept as the genuine note herein described any note which purports to b

14. Trustee may resign by instrument in writing filed in the office of the Recorder or Registrar of Titles in which this instrument shall have been recorded or filed. In case of the resignation, mability or refusal to act of Trustee, the then Recorder of Deeds of the county in which the premises are situated shall be Successor in Trust. Any Successor in Trust hereinder shall have the idential title, powers and authority as are herein given Trustee.

15. This Trust Deed and all provisions hereof, shall extend to and be binding upon Mortgagors and all persons claiming under or through Mortgagors, and the word "Mortgagors" when used herein chall include all such persons and all persons liable for the payment of the indebtedness or any part thereof, whether or not such persons shall have executed the note or this Trust Deed. The word "note" when used in this instrument shall be construed to mean "notes" when more than one note is used.

16. Before releasing this trust deed, Trustee or successor shall receive for its services a fee as determined by its rate schedule in effect when the release deed is issued. Trustee or successor shall be entitled to teasonable compensation for any other act or service performed under any provisions of this trust deed. The provisions of the "Trust And Trustees Act" of the State of Illinois shall be applicable to this trust deed.
