THE FOLLOWING ARE THE COVENANTS, CONDITIONS AND PROVISIONS REFERED TO ON PAGE 1 (THE REVERSE SIDE OF THIS TRUST DEED) AND WHICH FORM A PART OF THE TRUST DEED WHICH THERE BEGINS

- 1. Mortgegors shall (1) keep said premises in good condition and repair, without waste; (2) promptly repair, restore, or rebuild any buildings or improvements now or hereafter on the premises which may become demaged or be destroyed; (3) keep said premises free from mechanic's liens or liers in favor of the United States or other liens or claims for lien not expressly subordinated to the lien hereof; (4) pay when due any indebtedness which may be secured by a lien or charge on the premisers superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to holders of the note; (5) complete within a reasonable time any hielding or buildings now or at any time in process of exection upon said premises; (6) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (7) make no material alterations in said premises except as required by law or municipal ordinance or as previously consented to in writing by the Trustee or holders of the note.
- 2. Mortgagors shall pay before any pensity attaches all ganeral taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when eue, and shall, upon written request, furnish to Trussee or to holders of the note the original or deplicate receipts therefor. To prevent default hereunder Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagors may desire to contest.
- 3. Mortgagors shall keep all muldings and improvements now or hereafter situated on said pre-nises insured against loss or damage by fire, lightning and windstorm under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness secured hereby, all in companies satisfactory to the holders of the note, under insurance policies payable, in case of loss or damage, to Trustee for the benefit of the holders of the fines, such rights to be evidenced by the standard mortgage clause to be attached to each policy, and shall deliver all policies, including additional and renewal policies, to holders of the note, and in case of insurance about to expire, shall deliver renewal policies not less than ten days prior to the respective dates of expiration.
- 4. In case of-default therein, Trustee or the holders of the note may, but need not, make any payment or perform any act hereinbefore required of Mortgagots in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior encumbrances, if any, and purchase, discharge, compromise or settle any tax lien or other prior lien or title or claim thereof, or redeem from any tax sale or forfeiture affecting said premises or contest any tax or assessment. All moneys paid for any of the purposes herein authorized and all expenses paid or incurred in connection therewith, including reasonable attorneys fees, and any other moneys advasced by Trustee or the holders of the note to protect the mortgaged premises and the lien hereof, pius reasonable compensation to Trustee for each matter concerning which action herein authorized may be taken, shall be so much additional indebtedness secured hereby and shall become immediately due and payable without no ice and with interest thereon at the rate of seven per cent per annum. Inaction of Trustee or holders of the note shall never be considered as a water of any right accruing to them on account of any default hereunder on the part of Mortgagors.
- 5. The Trustee c, the holders of the note hereby secured making any payment hereby authorized relating to taxes or assessments, may do to according to any hill statement or estimate procured from the appropriate public office without inquiry into the accuracy of such hill, statement or estimate or into the validity of any tax, assessment, sale, forfeiture, tax lien or title or claim thereof.
- 6. Murragors shall ray rach item of indebtedness herein mentioned, both principal and interest, when due according to the terms hereof. At the election of the holders of use principal note, and without notice to Mortgagors, all unpaid indebtedness secured by this Trust Deed shall, notwiths, anything in the principal note or in this Trust Deed to the contrary, become due and payable when default shall occur in payment of principal or interest, or in case default shall occur and continue for three days in the performance of any other agreement of the Mortgagors herein contained.
- 7. When the indebtedness hereby is used shall become due whether by the terms of the note described on page one or by acceleration or otherwise, holders of the note or Tru \*\* shall have the right to foreclose the lien hereof and also shall have all other rights provided by the laws of Illinois for the enforcement of a mortgage libt. In any suit to foreclose the lien hereof, there shall be allowed and included as additional indebtedness in the decree for sale all expenditure and expenses which may be pall or incurred by or on behalf of Trustee or holders of the note for attempts, fees, Trustee's fees, appraiser's feer, or days for documentary and expert evidence, stemographers' charges, publication costs and costs (which may be estimated as to stems to be expended after entry of the decree) of procuring all such abstracts of title, title scarches and examinations, guarantee policies. Tourens certificates, and si alia, date and assurances with respect to title as Trustee or holders of the note may deem to be reasonably necessary either to prosecute such an tip the evidence to bidders at any sale which may be had pursuant to such dotre the true come to much additional indebtedness secured hereby and mentiately due and payable, with interest thereon at the rate of seven per cent per annum, when paid or incurred by Trustee or holders of the note in connection with (s) any action, suit or proceeding, including but not limited to probate and bankruptcy proceedings, to which either or the most limited to probate and bankruptcy proceedings, to which either or the commencement of any suit for the freedomme hereof after accrual of such right to foreclose whether or not actually commenced; or (c) not proceed and amplied in the following order of enjoying Eigst, or account the premises or the security hereof, whether or not actually commenced.

- 9. Upon or at any time after the filing of a complaint to foreclose thi. Thur Deed, the Court in which such complaint is filed may appoint a receiver of said premises. Such appointment may be made either before or after the without notice, without regard to the solvency or insolvency of Mortgagors at the time of application for such receiver and without regard to the premises or whether the same shall be then occurring as a homestead or not and the Trustee hereunder may be appointed as soci, it reciver. Such receiver shall have power to collect the rents, issues and profits of said primites during the pendency of such foreclesure suit and, in case of a safe and a deficiency, during the fell statutory period for redemption, whether there be redemption or not, as well as during any for their times when Mortgagors, except for the Intervention of such receiver, would be entitled to collect such tents, issues and profits, and all other powers and he may be mecassive or are usual in such cases for the particle the receiver to apply the net insched and operation. Trustee has no duty to examine the title, location, existence, or condition of the premises, nor chall Trustre be obligated to record this Trust Deed or to exercise any power herein given unless express, obligated by the terms hereof, nor be habit for any acts or omissions horeunder, except in case of his own gross negligence or misconduct or that of the agents or employees of Truster, and he may require indemnities satisfactory to him before exercising any power herein given.
- 13. Trustee shall release this Trust Deed and the lien thereof by proper instrument upon presentation of sati are dry evidence that all indebtedness secured by this Trust Deed has been fully paid; and Trustee may execute and deliver a release hereof to and at the request of any person who shall either before or after maturity thereof, produce and eshibit to Trustee the unincipal note, representing that all indebtedness hereby secured has been peid, which representation Trustee may accept as true without inquiry. Where a release is requested on a rucessor trustee, such successor trustee may accept as the genuine note herein described any note which bears a certificate of identification of porting to be executed by a prior trustee hereunder or which conforms in substance with the description herein contained of the principal so; and where the release is requested of the original trustee and he has never executed a certificate on any instrument identifying same as the principal note described herein, he may accept as the genuine principal note therein described any note which may be presented and which conforms in substance with the description herein contained of the principal note and which purports to be executed by the persons herein designated as makers thereof.
- 14. Trustee may resign by instrument in writing filed in the office of the Recorder or Registrar of Tities in which this instrument shall have been recorded or cited. In case of the death, resignation, inability or refusal to act of Trustee. Robert L. Soltis shall be first Successor in Trust and in the event of his or its death, resignation, inability or refusal to get, the then Recorder of Deeds of the county in which the premises are situated shall be second Successor in Trust. Any Successor in Trust hereunder shall have the identical title, powers and authority as are herein given Trustee, and any Trustee or successor shall be entitled to reasonable compensation for all acts performed hereunder.

This Trust Decil and all provisions hereof, shall extend to and be binding upon Mertgagors and all persons claiming under or through Mortgagors, and the word "Mortgagors" when used herein shall include all such persons and all persons at any time liable for the payment of the indebtedness or any part thereof, whether or not such persons shall have executed the principal note, or this Trust Deed.
