The thorice, without regard to the solvency or insolvency of Granton(s) at the time of application for such receiver and without regard to the then value of the premises or whether the same shall be then occupied as a homestead or not and the Trustee hereunder may be appointed as such receiver. Such receiver shall have power to collect the rents, issues and profits of said premises during the pendernay of such foreclosure suit and, in case of a sale and a deficiency, during the full statutory period of redemption, whether there be redemandour, as well as during any further times when Granton(s), except for the intervention of such receiver, would be entitled to collect such rents, issues and profits, and all other powers which may be necessary or are usual in such cases for the protection, possimion, control, management and operation of the premises during the whole of said period. 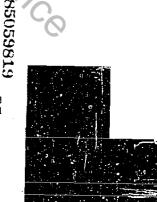
