ONE PAGE RIDER ATTACHED TO AND MADE PART OF TRUST DEED AND INSTALLMENT NOTE DATED JULY 16, 1985, FROM RAFAEL RODRIGUEZ, TO CHICAGO TITLE AND TRUST COMPANY AS TRUSTEE FOR MORTGAGEE.

- i. The undersigned covenants and agrees that they will not transfer or suffer an involuntary transfer of any interest, whether legal or equitable, and whether possessary or otherwise in the mortgaged premises, to any third party, without the advance writter consent of the holder of this Note, and further that in the event of any such transfer by the undersigned without the advance written consent of the holder of this Note, said holder may, in its or their sole discretion and without notice, declare the whole of the debts hereby immediately due and payable. Any assumption agreed to in writing by owner and holder shall not constitute release of mortgagor.
- 2. The undersigned shall have the right to prepay this indebtedness at any time, in whole without payment of any premium or penalty whatsoever.
- 3. Notwithstanding the aforementioned provisions, the mortgagor shall be allowed a ten (10) day grace period on their monthly installments. If payment is not received on the tenth day of the date oue, a Ten (10%) percent penalty of the amount then due shall be assessed and due with said payment. Any penalty not paid shall continue to accrue till paid. The amount due shall be construed to mean the monthly payment.
- 4. The maker hereof hereby agrees to deposit monthly with the holder of this mortgage and note, a sum equal to I/I2th of the annual real estate taxes and insurance at option of lender.
