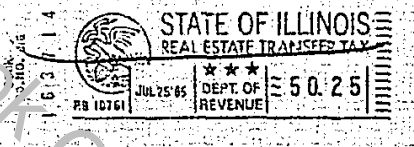
This Indenture, Made this 7th day of June 1985 A. D. 1985
