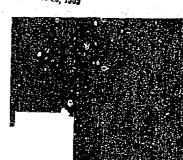

- CS OF ITTE 14 000 Mortgagors shall ial promotivited. damaged or be destroyed, (b) keep said premises in good condition and repair, without waste, and froe from mechanic's or other term or claims for lien not expressly subprigrouted to the tien hereof, (or pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the first hereof, and upon request enhibit satisfactory evidence of the discharge of such prior tien to Trustee or to holders of the note; (discomplete within a reasonable time any fullding or buildings now or at any time in process of erection upon said premises; (e) comply with all requirements of taw or with respect to the premises and the use thereof; (I) make no material alterations in said premises except as required by law or
- 2. Mortgagors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall, upon written request, furnish to Trustee or to holders of the note duplicate receipts therefor. To prevent default hereunder Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagors may desire to contest.
- Mortgagors shall keep all buildings and improvements now or hereafter situated on said premises insured against loss or damage by fire, lightning or windstorm (and flood damage, where the lender is required by law to have its loan so Insured) under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness secured hereby, all in companies satisfactory to the holders of the note, under insurance policies payable, in case of loss or damage, to Trustee for the benefit of the roders of the note, such rights to be endenced by the standard mortgage clause to be attached to each policy, and shall deliver all policies, including additional and mnewal policies, to holders of the note, and in case of insurance about to expire, shall deliver renewal policies not less than ten days prior to the respective dates of expiration.
- 4. In case of default therein, Trustee or the holders of the note may, but need not, make any payment or perform any act hereinbefore required of Mortgagors in any form and manner deemed excedent, and may, but need not, make full or partial payments of principal or interest on prior encumbrances, if any, and purchase, discharge, compromise or settle any tax filen or other prior tien or fittle or claim thereof, or redeem from any tax sale or fortering all premises or contest any tax or assessment. Trustee shall release this trust deed and the lien thereof by proper instrument upon presentation or satisfactory evidence that all indebtedness secured by this trust deed has been fully paid; and Trustee may execute and deliver a release hereof to and at the request of any person who shall, either before or after maturity thereof, produce and exhibit to Trustee the note, representing that all indebtedness hereby secured has been paid, which represents may except as true without fingular, Vithere a release is requested of a successor trustee, such successor trustee may accept. Any Successor in Trust hereunder shall have the idential title, powers and authority as are here in given Trustee.
- 15. This Trust Deed and all provisions hereof, shall extend to and be binding upon Mortgagors and all persons claiming under or through Mortgagors, and the word "Mortgagors" when used herein shall include all such persons and all persons liable for the payment of the indeptedness or any part thereof, whether or not such persons shall have executed the note of this Trust Deed. The word "note" when used in this instrument shall be construed. to mean "notes" when more than one note is used.
- 16. Before releasing this trust deed. Trustee or successor shall receive for its services afee as determined by its rate schedule in effect when the release Good is issued. Trustee or successor shall be entitled to reasonable compensation for any other act or service performed under any provisions of this trust deed. The provisions of the "Trust And Trustees Act" of the State of Illinois shall be applicable to this trust deed.
