

ASSIGNMENT OF RENTS

NORTH SHORE NATIONAL BANK OF CHICAGO

or its agents, due or to become due, or that may hereafter be contracted, and also to the payment of all expenses and the care and management of said premises, including taxes and assessments, and the interest on encumbrances, if any, which may be in its judgement deemed proper and advisable.

This instrument is given to secure payment of the principal sum and interest of or upon a certain loan for One million five hundred thousand & no/100 dollars secured by a Mortgage or Trust Deed dated the 1st day of June, 1985 conveying and mortgaging the real estate and premises hereinabove described to NORTH SHORE NATIONAL BANK OF CHICAGO, as Trustee
