Mortgagor shall keep the improvements of the Preceity insular against any ics or samage occasioned by fire, extended coverage perils and such other hazards as Mortgagee may require, through insurers approved by Mortgagee, in amounts not less than the unpaid balance of the Indebtedness plus any other indebtedness secured by the Property, without co-insurance. Mortgagor waives any right of set off against any person in possession of any portion of the Property. Mortgagor agrees not to further assign any of the rents or profits of the Property

Nothing herein contained shall be construed as constituting the Mortgagee a mortgagee in postess or in the absence of the taking of actual possession of the Property by the Mortgagee. In the exercise of the powers herein granted-fire gagee, no liability shall be asserted or enforced against Mortgagee, all such liability being expressly waived and released by Mortgager.
