#### Excerpts From Internal Revenue Code

#### Sec. 6321. Lien For Taxes.

If any person liable to pay any tax neglects or refuses to pay the same after demand, the amount finctuding any intersest, additional amount, addition to tax, or assessable penalty; together with any costs that may accrus in addition thereto shall be a tren in taxor of the United States upon all property and rights to property, whether teal or personal belonging—to such person

#### Sec. 6322. Period Of Lien.

Unless another date is specifically fixed by law, the lien timposed by section 6321 shall arise at the time the assessment is made and shall continue until the Hability for the amount so assessed (or a judgment against the taxpayer arising out of such hability) is satisfied or becomes unenforceable by reason of lapse of time.

### Sec. 6323. Validity and Priority Against Certain Persons.

(a) Purchaser's, Holders Of Security Interests; Mechanic's Lienors, And Judgment Lien Creditors. — The lien imposed by section 6321 shall not be valid as against any purchaser, holder of a security interest, mechanic's lienor, or judgment fron creditor until natice thereof, which meets the requirements of subsection (f) has been filled by the Societary.

(ii) Personal Property - In the case of personal property, whether tangible or intangible, in one office within the State for the county, or other governmental subdivision), as designated by the laws of such State, in which the property subject to the lien is situated; or

(8). With Clerk Of District Court - In the office of the clerk of the United States district court for the judicial district in which the property subject to tien is situated, whenever the State has not by law designated one office which meets the requirements of subparagraph (A), or

(C) With Recorder Of Deeds Of The District Of Columbia - In the office of the Recorder of Deeds of the District of Columbia it the property subject to the Iren is situated in the District of Columbia. - (9) Refiling Of Notice. For purposes of this section.
- (1) General Rule. Unless notice of lien is refiled in the manner prescribed in paragraph (2) during the required refiling period such notice of lien shall be treated as filed on the date on which it is filed in accordance with subsection (1) after the expiration of such refiling period.

- ta) Release Of Lien. Subject to such regulations as the Secretary may presenbe, the Secretary shall issue a certificate of release of any tien imposed with respect to any internal revenue (ax not later than 30 days after the day on
- (i) Liability Satisfied or Unenforceable The Sucretary finds that the liability for the amount assessed, together with all literast in respect thereof, has been fully satisfied or has become legally unenforceable; or
