WHEREAS, The City Council of the City of Chicago, after due investigation and consideration, has determined that the nature and extent of the public use and the public interest to be subserved is such as to warrant the vacation of public alley and part of the public alley described in the following ordinance; now, therefore,

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. That all that part of the north-south 16-foot public alley dedicated by plat recorded Mry 14, 1959, as Document No. 17536792 and described as follows:

The east 18 lest of the west 17 feet of Lot 43 in Pope's Subdivision of Lots 1, 2, 3, 4, 10, 11, 12 and 13 all in Block 8 in Cook and Anderson's Subdivision of the west 1/2 of the Northeast 1/4 of Section 24. Township 39 North, Range 13 East of the Third Principal Meridian, in Cook Collect, Illinois.

that part of the east-west 16-foot public piley lying south of the south line of Lots 24 and 33, both inclusive; lying north of the north line of Lots 34 and 43, both inclusive; lying east of a line drawn from the southwest corner of Lot 33 to the northwest corner of Lot 34; and lying west of a line drawn from the northwest corner of Lot 44 to the southwest corner of Lot 23, all in Pope's Subdivision aforementioned; said public alley and part of public alley herein vacated being further described as all of the north south 16-foot public alley and all of the remaining east-west 16-foot public alley in the block counded by W. 15th Place, W. 16th Street, S. Washtenaw Avenue, and S. Rockwell Street as colored in red and indicated by the words "To Be Vacated" on the drawing hereto attach d, which drawing for greater certainty, is hereby made a part of this ordinance, be and the seme are hereby vacated and closed, inasmuch as the same are no longer required for public use and the public interest will be subserved by such vacations.

SECTION 2. The vacations herein provided for are made upon the express condition that within 90 days after the passage of this ordinance, Joseph T. Ryerson and S.m. Inc. shall pay or cause to be paid to the City of Chicago as compensation for the benefits which will accrue to owner of the property abutting said public alley and part of the public alley hereby vacated, the sum of Thirteen Thousand Seven Hundred and no/100 Collars (\$13,700.00), which sum in the judgment of this body will be equal to such benefits; and further, shall within 90 days after the passage of this ordinance, deposit in the City Treasury of the City of Chicago a sum sufficient to defray the costs of removing paving and curb returns and constructing sidewalk and curb across the entrances to the public alley and part of public alley hereby vacated, similar to the sidewalk and curb in S. Washtenaw Avenue and W. 16th Street. The precise amount of the sum so deposited shall be ascertained by the Commissioner of Public Works after such investigation as is requisite.

SECTION 3. The vacations herein provided for are made upon the express condition that within 90 days after the passage of this ordinance, the Joseph T. Ryerson and Son, Inc. shall file or cause to be filed for record in the Office of the Recorder of Deeds of Cook County, Illinois, a ceritized copy of this ordinance, together with an attached drawing approved by the Superintendent of Maps.

SECTION 4. This ordinance shall take effect and be in force from and after its passage.
