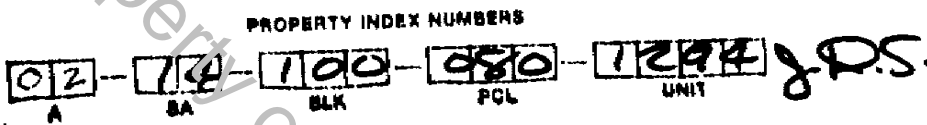
PARCEL 1:
