THIS RELEASE DEED, executed and delivered this 28<sup>th</sup> day of August, 1984, by REPUBLICBANK DALLAS, N.A., a national banking association.

W I T N E S S E T H:

A. American National Bank and Trust Company of Chicago, a national banking association, as Trustee under the provisions of Trust Agreement No. 59343 (the "Trust"), dated October 5, 1983, executed and delivered to Vancorp Finance Company of Texas, Inc. (Vancorp), a Texas corporation, a certain Mortgage and Security Agreement (the "Mortgage"), dated October 25, 1983, and recorded as Document No. 26,837,415 in the Records of Cook County, Illinois and an Assignment of Landlord's Interest in Leases (the "Assignment"), dated of even date therewith and recorded as Document No. 26,837,416 in the Records of Cook County, Illinois, said Mortgage and Assignment (i) covering the real property and improvements situated thereon located in Cook County, Illinois, being more particularly described on Exhibit "A" attached hereto and made a part hereof for all purposes (all property covered by the Mortgage and Assignment shall hereinafter be referred to as the "Property") and (ii) securing the payment of a Revolving Credit Note (the "Note"), dated June 14, 1983, in the original principal amount of \$150,000,000.00, executed by the beneficiary of the Trust, Vantage Properties, Inc. ("Vantage"), a Texas corporation, and payable to the order of Vancorp.

B. Vancorp has assigned to Republic all of its right, title and interest in and to the Note, the Mortgage and the Assignment pursuant to that certain Assignment of Note,

C. Vancorp has paid to Republic a certain sum of money in order to reduce the outstanding balance of principal and interest under the Note and to induce Republic to execute this Release Deed.

NOW, THEREFORE, in consideration of the payment of such sum by Vancorp to Republic, and other good and valuable consideration, the sufficiency of which is hereby acknowledged and confessed, and pursuant to the provisions of that certain letter from Vancorp to Republic, dated as of even date herewith, requesting Republic to execute this Release Deed, Republic has this day and by these presents does hereby, RELEASE, DISCHARGE and QUITCLAIM unto Vantage, its successors and assigns, all right, title and interest it may have acquired by virtue of the Mortgage and the Assignment, and Republic does hereby declare the Property fully released and discharged from any and all liens created by virtue of the Mortgage and the Assignment.
