

satisfactions of mortgages so signed shall be valid instruments of the Company.

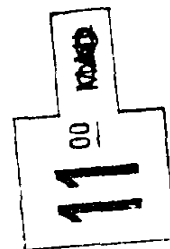
