## Excerpts From Internal Revenue Code

### Sec. 6321. Lien For Taxes.

If any person liable to pay any tax neglects or refuses to pay the same after demand, the amount including any interest, additional amount, addition to tax, or assessable penalty, together with any costs that may accrue in addition thereto, shall be a lien in favor of the United States upon all property and rights to property, whether real or personal, belonging to such person, or measureable to it.

### Sec. 6322. Period of Lien.

Unless another date is specifically fixed by law, the lien under section 6321 shall arise at the time the liability is recognized by statute and shall continue until the liability (or the amount so assessed (or a judgment against the taxpayer arising out of such liability)) is satisfied or becomes unenforceable by reason of lapse of time.

### Sec. 6323. Validity and Priority Against Certain Persons.

(a) Purchaser, Holders Of Security Interests, Mechanics' Liens, And Judgment Lien Creditors. — The lien imposed by section 6321 shall not be valid as against any purchaser, holder of a security interest, mechanic's lien, or judgment lien creditor until notice thereof which meets the requirements of subsection (1) has been filed by the Secretary.

(b) Protection For Certain Interests Even Though Notice Filled. — Even though notice of a lien imposed by section 6321 has been filed, such lien shall not be valid.

#### (c) Place For Filing Notice; Form.

(1) Place For Filing. — The notice referred to in subsection (a) shall be filed —

(a) With Clerk Of Court.

(i) Real Property — In the case of real property, in one office within the State for the county, or other governmental subdivision, as designated by the laws of such State, in which the property subject to the lien is situated; and

(ii) (A) Personal Property. — In the case of personal property, whether tangible or intangible, in one office within the State for the county, or other governmental subdivision, as designated by the laws of such State, in which the property subject to the lien is situated; or

(B) With Clerk Of District Court. — In the office of the clerk of the United States district court for the judicial district in which the property subject to lien is situated, whenever the State has not by law designated one office

for the purpose of filing notices of liens.

(2) Notice of Lien. — The notice of lien shall be in writing and shall contain the following information:

(a) Name and address of the taxpayer;

(c) Description of the property subject to the lien;

(d) Amount of the tax, interest, and penalties;

(e) Date of assessment or date of filing of the notice;

(f) Date of filing of the notice;
