UNIFORM COVENANTS. Borrower and Lender covenant and agree as follows:

1. Payment of Principal and Interest. Borrower shall promptly pay when due the principal of and interest on the indebtedness evidenced by the Note, prepayment and late charges as provided in the Note, and the principal of and interest on any Future Advances secured by this Mortgage.

2. Funds for Taxes and Insurance. Subject to applicable law or to a written waiver by Lender, Borrower shall pay to Lender on the day monthly installments of principal and interest are payable under the Note, until the Note is paid in full, a sum (herein "Funds") equal to one-twelfth of the yearly taxes and assessments which may attain priority over this Mortgage, and ground rents on the Property, if any, plus one-twelfth of yearly premium installments for hazard insurance, plus one-twelfth of yearly premium installments for mortgage insurance, if any, all as reasonably estimated initially and from

This Rider is attached to and made a part of that certain Mortgage (the "Mortgage") between Borrower and Lender with respect to 6041 W. Roscoe, Chicago, Illinois. Unless otherwise stated, defined terms herein have the same meaning as in the Mortgage. If there is any conflict between the terms of this Rider and the Mortgage, the terms of this Rider shall control.

1. Transfer of the Property; Assumption. If (i) all or any part of the Property or an interest therein is sold or transferred by Borrower without Lender's prior written consent; (ii) the Property ever ceases to be occupied by the Borrower as her main residence; (iii) Borrower encumbers the Property with any additional liens or encumbrances, whether or not secondary to this mortgage, or (iv) Borrower's employment with Barclays Bank PLC terminates for any reason other than normal retirement, Lender may at Lender's option, declare all the sums secured by this Mortgage to be immediately due and payable.

Notwiths landing the foregoing, if Borrower's employment with Barclays Bank FLC terminates for any reason other than a dismissal for cause of under circumstances which would justify such dismissal for cause, Lerder shall not declare all sums secured by this mortgage due, if Borrower elects to continue the Note under the modified terms hereinafter described, and executes modification documents acceptable to Lender within four (4) months of Borrower's termination.
