(hereinafter referred to as "owner") of Barrington Hills, Chicago County of Cook, State of Illinois and states: That on May 30 1985, the owner owned the following described land in the County of Cook, State of Illinois to wit: 61 Hawley Wood Road, Barrington Hills, Illinois A/K/A: Lots 22 and 22A Hawthorn Hills in the West one-half of the Northwest one-quarter in Sections 2, 10 and 11 all in Township 42 North, Range 9 East of the Third PM also Lots 1 and 1A of Woodens Re-division of Lots 23, 23A, 24, 24A, 25, 25A, 26, 26A of Hawthorn Hills Subdivision in the Northeast one-quarter of Section 10, Township 42 North, Range 9 East of the Third PM A/K/A: 01-11-103-045 and 041

That said contractor is entitled to credits of account thereof as follows: NONE, leaving due unpaid and owing to the claimant, after allowing all credits, the sum of Eleven Thousand and 00/100ths. (\$11,000.00) Dollars, for which, with interest, the claimant claims a lien on said land and improvements, and on the moneys or other considerations due or to become due from the owner under said contract against said contractor and owner.
