An undivided one-quarter interest in:

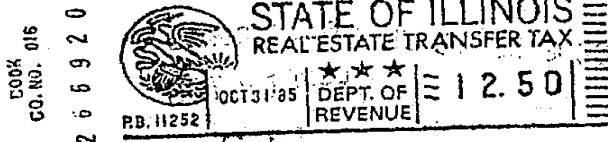
