## AFFIDAVIT

WHEREAS, THE Village of Northbrook did, by Ordinance No. 85-71, dated October 22, 1985, voluntarily annex the following described contiguous territory in accordance with Article 7, Division 1, Section 8 of the Illinois Municipal Code:

That part of the west half of the Northwest quarter of Section 22, Township 42 North, Range 12, East of the Third Principal Meridian, bounded and described as follows: Beginning at a point in the center line of Willow Road, 120 feet Southeasterly measured at right angles, from the center line between the two main tracks, of the Chicago and Northwestern Railroad Company; thence Northeasterly parallel with said center line a distance of 700.0 feet to a point, thence Northwesterly at right angles to the last described course a distance of 58.49 feet to a point distance 55.0 feet Southeasterly, measured at right angles from the center line of the most Southeasterly or Eastbound track; thence Southwesterly parallel with said main track centerline a distance of 740.93 feet to a point on the center line of Willow Road; thence Easterly along said center line of Willow Road to the point of beginning, all in Cook County, Illinois, commonly designated as 1900 Willow Road, Northbrook, Illinois (PREI Number 04-22-100-025)

all of which territory is not within the corporate limits of any municipality and is contiguous to the Village of Northbrook, Illinois.

WHEREAS, such territory was previously unincorporated and a part of the Northbrook Rural Fire Protection District; and

WHEREAS, Article 7, Division 1, Section 1 of the Illinois Municipal Code requires notification of proposed annexation to be provided to the applicable Fire Protection District;

### IT IS, THEREFORE, CERTIFIED THAT:

- 1) The Trustees of the Northbrook Rural Fire Protection District acknowledge full and proper receipt of notification by the Village of Northbrook of the proposed annexation above described.
- 2) The Northbrook Rural Fire Protection District acknowledges and understands the necessity for such annexation and has no objection to the recordation of such action by the Village of Northbrook.
- 3) The Northbrook Rural Fire Protection District hereby releases, effective this date, all responsibility for fire protection in and to the subject land area to the Village of Northbrook.

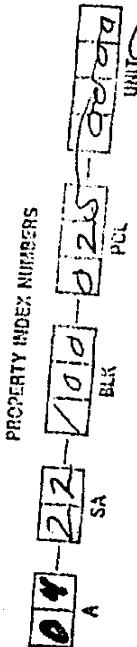
