WHEREAS, THE Village of Northbrook did, by Ordinance No. 85-71, dated 1985, voluntarily annex the following described continguous pritory in accordance with Article 7, Division 1, Section 8 of the Illinois icipal Code:

> That part of the west half of the Northwest quarter of Section 22, Township 42 North, Range 12, East of the Third Principal Meridian, bounded and described as follows: Beginning at a point in the center line of Willow Road, 120 feet Southeasterly measured at right angles, from the tenter line between the two main tracks, of the Chicago and Northwestern Railroad Company; thence Northeasterly rarallel with said center line a distance of 700.0 feet to a roint, thence Northwesterly at right angles to the last described course a distance of 58.49 feet to a point distance 55.0 feet Southeasterly, measured at right angles from the center line of the most Southeasterly or Eastbound track; thence Southwesterly parallel with said main track centerline a distance of 740.93 feet to a point on the center line of Willow Road; thence Easterly along said center line of Willow Road to the point of beginning, all in Cook Courty, Illinois, commonly designated as 1900 Willow Road, Northbrook, Illinois (PREI Number 04-22-100-

- The Northbrook Rural File Protection District acknowledges and understands the necessity for such annexation and has no objection to the recordation of such action by the Village of Northbrook.
- The Northbrook Rural Fire Protection District hereby releases, effective this date, all responsibility for fire protection in and to the subject land area to the Village of Northbrook.
