TEMPORARY RESTRAINING ORDER

This matter is coming on to be heard on the motion of the People of the State of Illinois, moving the Court to impound, seize and hold the assets described in Exhibit A of their motion and to issue a Temporary Restraining Order restraining Cesar Perez and Ana Lillian Perez, the Defendants, and all persons acting in concert with the Defendants from taking any action to interfere with the Court's impoundment. The Court being fully advised of the premises and a sufficient showing that immediate and irreparable loss will result to the People if notice is given to the Defendant in that he will be able to remove from the jurisdiction of the court, conceal, destroy, or otherwise dispose of property which may be subject to forfeiture under the Narcotics Profit Forfeiture Act, it is hereby ordered:

1. THAT the property listed in Exhibit A, be impounded, seized and held by this Court pending trial of charges against the Defendants under the Narcotics Profit Forfeiture Act.
2. THAT Cesar Perez and Ana Lillian Perez, the Defendants, and all persons acting in concert with him and her shall be temporarily restrained from taking any action to interfere with this court's impoundment of the assets described in Exhibit A.
3. THAT this Order expire within ten (10) days after entry unless within such time the Order for good cause is extended or unless the Defendants consent that it may be extended for a longer period.
