The above named taxpayer has filed his return for the taxable year ending December 31, 1965, showing an unpaid tax liability of \$1,000.00. A copy of his return is attached hereto. A copy of the notice is also attached. This notice serves as a notice of the filing of a tax lien in favor of the United States against the above named taxpayer for the amount of \$1,000.00.

EXPLANATION OF AMOUNT

Excerpts From Internal Revenue Code

Sec. 6321. Lien For Taxes.

If any person liable to pay any tax neglects or refuses to pay the same after demand, the amount including any interest, penalties, or additional amount, addition to tax, or assessable penalty, together with any costs that may accrue in addition thereto, shall be a lien in favor of the United States upon all property and rights to property held or personal, holding or claimed, or in the case of tangible or intangible, at the residence or place of business of the taxpayer at the time the notice of lien is filed.

Sec. 6322. Period of Lien.

Unless another date is specifically fixed by law, the lien imposed by section 6321 shall arise at the time the assessment is made and shall continue until the liability is paid, so assessed (or a judgment against the taxpayer arising out of such liability) is satisfied or becomes unenforceable by reason of lapse of time.

Sec. 6323. Validity and Priority Against Certain Persons.

(a) Purchaser's, Holders Of Security Interests, Mechanic's Liens, And Judgment Lien Creditors. — The lien imposed by section 6321 shall not be valid as against any purchaser, holder of a security interest, mechanic's lien, or judgment lien creditor until notice thereof which meets the requirements of subsection (f) has been filed by the Secretary.

(b) Protection For Certain Interests Even Though Notice Filed. — Even though notice of a lien imposed by section 6321 has been filed, such lien shall not be valid.

(c) Place For Filing Notice; Form.

(1) Place For Filing. — The notice referred to in subsection (a) shall be filed—

(A) Under State Laws.—

(i) Real Property. — In the case of real property, in one office within the State (or the county, or other governmental subdivision), as designated by the laws of such State, in which the property subject to the lien is situated; and

(ii) no. (i). Personal Property. — In the case of personal property, whether tangible or intangible, in one office within the State (or the county, or other governmental subdivision), as designated by the laws of such State, in which the property subject to the lien is situated; or

(B) With Clerk Of District Court. — In the office of the clerk of the United States district court for the judicial district in which the property subject to lien is situated, whenever the State has not by law designated one office.

which meets the requirements of subparagraph (A); or

(c) With Recorder Of Deeds Of The District Of Columbia. — In the office of the Recorder of Deeds of the District of Columbia, if the property subject to the lien is situated in the District of Columbia.

(iv) Sites Of Property Subject To Lien. — For purposes

of paragraphs (1) and (4), property shall be deemed to be situated

at the place where it is used, occupied, or held.

(v) Personal Property. — In the case of personal

property, whether tangible or intangible, at the residence

or place of business of the taxpayer at the time the notice of

lien is filed.

For purpose of paragraph (2), (B), the residence of a corporation or partnership shall be deemed to be the place at which the principal executive office of the business is located, and the residence of a taxpayer whose residence is without the United States shall be deemed to be in the District of Columbia.

(3) Form. — The form and content of the notice referred to in subsection (a) shall be described by the Secretary. Such notice shall be valid notwithstanding any other provision of law regarding the form or content of a notice of lien.

(g) Refiling Of Notice. — For purposes of this section—

(1) General Rule. — Unless notice of lien is filed in the manner prescribed in paragraph (2) during the required refiling period, such notice of lien shall be treated as filed on the date on which it is filed (in accordance with subsection (f)) after the expiration of such refiling period.

(2) Place For Filing. — A notice of lien filed during the required refiling period shall be effective only—

(i) such notice of lien is filed in the office in which the prior notice of lien was filed; and

(ii) in the case of real property, the fact of refiling is entered and recorded in an index to the paper required by subsection (Q) (2); and

(iii) in any case in which 90 days of time refer to the date of a refiling of notice of lien under subparagraph (A), the Secretary received written information (in the manner prescribed in regulations issued by the Secretary) concerning a change in the taxpayer's residence. If a notice of such lien is also filed in accordance with subsection (f) in the State in which such residence is located,

(5) Required Refiling Period. — In the case of

any other period ending 30 days after the expiration of 8 years after the date of the assessment of the tax, and

(b) the one-year period ending with the expiration of 8 years after the close of the preceding taxable period for each notice of lien.

Sec. 6325. Release Of Lien Or Discharge Of Property.

(a) Release Of Lien. — Subject to such regulations as the Secretary may prescribe, the Secretary may issue a certificate of release of any lien imposed with respect to any internal revenue tax if—

(i) Liability Satisfied or Unenforceable. — The Secretary finds that the liability for the amount assessed, together with all interest in respect thereof, has been fully satisfied or has become legally unenforceable; or

(ii) Bond Accepted. — There is furnished to the Secretary and accepted by him a bond that is conditioned upon the payment of the amount assessed, together with all interest in respect thereof, within the time prescribed by law (including any extension of such time), and that is in accordance with such requirements relating to terms, conditions, and form of the bond and sureties thereon, as may be specified by such regulations.

Sec. 6323. Confidentiality and Disclosure of Returns and Return Information.

(e) Disclosure of Certain Returns and Return Information For Tax Administration Purposes.

(2) Disclosure of amount of outstanding lien. — If a notice of lien has been filed pursuant to section 6323(f), the amount of the outstanding obligation imposed by such lien may be disclosed to any person who furnishes satisfactory written evidence that he has a right in the property subject to such lien or intends to obtain a right in such property.
