MEMORANDUM OF LEASE

This Memorandum Of Lease is made October 13, 1985 between Francis J. Cuneo, Agent and Attorney In Fact of the Lawrence A. Cuneo Testamentary Trust (June 29, 1979) and the Cassaretto Trust No. 1 (January 17, 1929) with office at Three First National Plaza, Chicago, Illinois 60602, "LANDLORD" and McCrory Corporation, a Delaware Corporation having offices at 888 Seventh Avenue, New York, New York, 10106, "TENANT", who agree as follows:

1. LANDLORD leases to TENANT and TENANT leases from LANDLORD property located in the City of Chicago, County of Cook, State of Illinois described in Exhibit attached to this Memorandum Of Lease for a term of 15 years commencing January 1, 1986, which term is subject to two, five year extensions by TENANT, on the provisions of lease between the parties. These provisions are incorporated herein by reference.

2. LANDLORD grants to TENANT, an option until January 1, 1986 to rent adjoining premises (described in Exhibit hereto) at 1952 to 1954 Lawrence Avenue pursuant to Article 39 of said lease.

This Memorandum Of Lease is prepared for the purpose of recordation, and in no way modifies the provisions of the said lease.

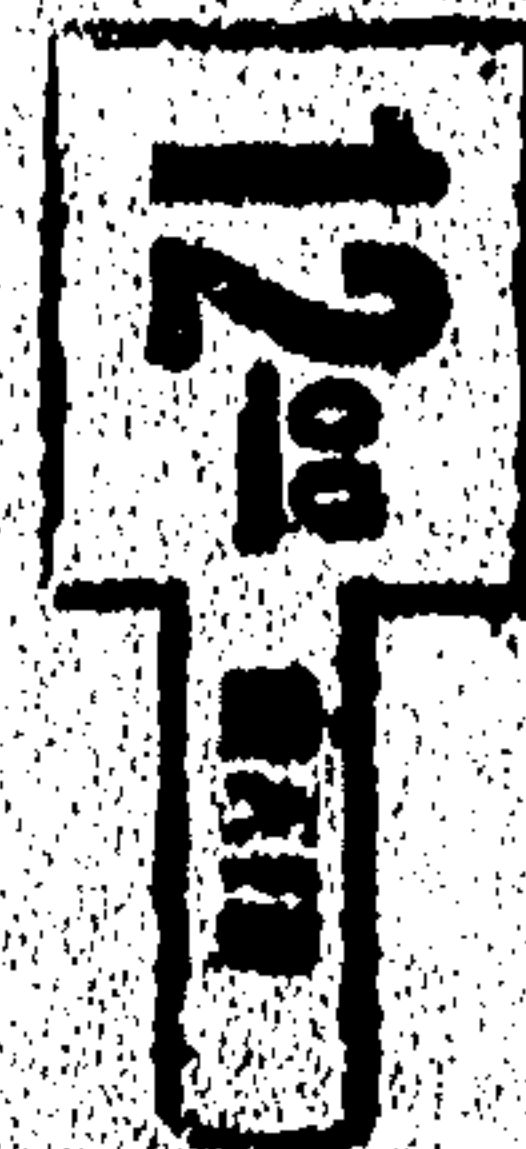
