

ASSIGNMENT OF REAL ESTATE MORTGAGE

KNOW ALL MEN BY THESE PRESENTS: That THE FIRST NATIONAL BANK OF CHICAGO, a national banking association ("Assignor"), whose address is One First National Plaza, Chicago, Illinois 60670, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, has granted, bargained, sold, assigned, transferred and set over, and by these presents does grant, bargain, sell, transfer assign and set over (without recourse except as set forth in a certain Whole Loan Sale and Servicing Agreement (Aujustable Rate Loans) between Assignor and Assignee dated August 23, 1985) unto ST. PAUL FEDERAL BANK FOR SAVINGS, a federal savings bank, whose address is 6700 West North Avenue, Chicago, Illinois 60635 ("Assignee"), all of Assignor's right, title and interest in the following:



(1) A certain mortgage ("Mortgage") made and executed by ROBERT R. BOURKE AND MARTORIE BOURKE HUSBAND AND WIFE

for the principal sum of ONE HINDRED DOCKARS FORTY-FOUR THOUSAND FIVE (\$144.500.00), which Mortgage was filed for record in the HUNDRED AND NO/100 office of the Recorder of Deeds of COOK County, Illinois, on MARCH 19, 1981, time Book Page , land filed for record in the office of the Registrar of Forcens Titles of Cook County, Illinois, on 19, as Document No. covering the premists situated in the County of Cook and State of Illinois, described as set forth on Exhibit A attached hereto and made a part hereof].**

(2) The debt secured by said Mortgage and the Note ("Note") evidencing such debt, with interest at the rate therein recited, and any assignments of leases and rents, security agreements, or other security specifically granted for such debt.

TO HAVE AND TO HOLD the same unto Assignee, i's successors and assigns forever.

Assignor does, for itself, its successors and assigns, covenant with Assignee that it is the legal and equitable owner of said Note and Mortgage with full power to sell and assign the same; that to the best of Assignor's knowledge there are no defenses, setoffs or counterclaims to said indebtedness secured by the Note and Mortgage; that it has executed no release, discharge, satisfaction or cancellation of any portion of said Note or Mortgage except for any instrument delivered to Assignee; that it has executed no release of any portion of the security described in said Mortgage except for any instrument delivered to Assignee; and that it has executed no instrument of any kind affecting the Mortgage or the Note or the liability of the maker or makers thereof except for any instrument delivered to Assignee.
