of said party of the second part.

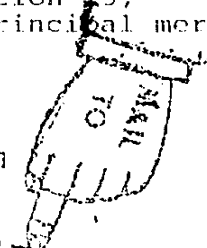

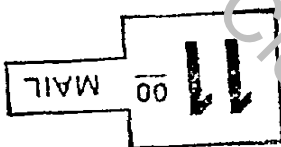
