8. On June 24, 1985, Developer caused to be recorded as Document No. 85072911 Supplement No. 7 to the aforesaid Declaration, (such Declaration, as amended and supplemented, being hereinafter referred to as the "Declaration"); and,

9. Developer desires to further supplement the Declaration by submitting additional property to the terms thereof, in accordance with the terms and conditions thereof.

Except as herein supplemented, all other provisions of the Declaration shall remain in full force and effect. In the event of any inconsistency between the terms hereof and those of the

Declaration, the terms hereof shall be controlling.

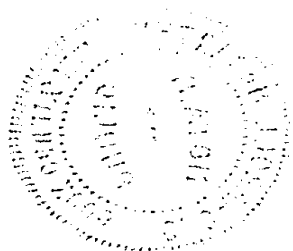
