LEGAL DESCRIPTION

PARCEL 1:

Block 1 in Northwestern University Subdivision, being a part of Sections 7 and 18, Township 41 North, Range 14 East of the Third Principal Meridian according to the plat thereof recorded February 13, 1875 as Document Number 13935, in Cook County, Illinois.

PARCEL 2:

That part of Lake Michigan lying East of and adjoining those portions of fractional Section 7 and 18, Township 41 North, Range 14 East of the Third Principal Meridian, occupied by the campus of Northwestern University and more particularly described as follows: Beginning at a point, being the intersection of the shore line of Lake Michigan and a line 325 feet South of and parallel to the South line of Lincoln Street. thence East along a line perpendicular to the East line of Sheridan Road to a point 2500 feet East of the East line of Sheridan Road; thence South along a line 2500 feet East of and parallel to the East line of Sheridan Road a distance of 3700 feet; thence West along a line perpendicular to the East line of Sheridan Road to the shore line of Lake Michigan; thence Northerly along said shore to the point of beginning in Cook County, Illinois.
