- I. Grantors shall (1) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (2) keep and premises in good condition and repair, without wasts, and five from mechanic's or other lieux or claims for lieu not expressly subordinated to the lieu hereof. (3) pay when due any indebtedness which may be secured by a lieu or charge on the premises superior to the lieu hereof, and upon request exhibit satisfactory evidence of the displaying of web print [ab ]et Trustee or to Beneficiary; (4) complete within a reasonable time any holidings now or at any time in process of erection upon said premises. (5) comply with all requirementally law britishness of dimances with respect to the premises and the use thereof. - Grantors shall pay before any penalty attaches all general lazes, and shall pay special taxes, apenal assessments, water charges, sever service charges, and other charges against the premises when
  due, and shall, upon written request, furnish to Trustee or to Beneficiary suplies to receipts therefor. To prevent default becomes charges shall pay in full under pretest, in the manner provided by statute,
  any tax or assessment which Grantor may desire to contest.
- 3. Grantors shall keep all buildings and improvements now or hereafter situated on and premises insured against loss or damage by fire, lightning or windstorm under policies previding for payment by the insurance companies of moneys sufficient either to pay the sost of replacing or repairing the same or to pay in full the indebtedness accurate hereby, all in companies satisfactory to the Beneficiary, and rights to be evidenced by the standard mortgage clause to be attached to each policy, and shall deliver all policies, including additional and renewal policies, to Beneficiary, and in case of insurance about to expire, shall deliver renewal policies not less than ten days prior to the respective dates of expiration.
- 4. In case of default therein, Trustee or Beneficiary may, but need not, make any payment or perform any act hereinbefore required of Grantors in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior encumbrances, if any, and purchase, discharge, compromise or settle any tax lies or other prior less than the prior lies of forfoiture affecting asid premises or contest any tax in or other prior less than thereof, or session and all premises or contest any tax or assessment.
