WHEREAS, a petition under oath, signed by the owners of record of the land hereinafter described, has been filed with the Village Clerk of the Village of Orland Park; and

WHEREAS, the Petition for Annexation complies in all respects with Chapter 24, Section 7-1-1 et seq. of the Illinois Revised Statutes; and

WHEREAS, proper notice has been provided to the Township Commissioner of Highways, the Board of Town Auditors, and the Fire Protection and Library Districts, where necessary; and

WHEREAS, the President and Board of Trustees have approved and executed an annexation agreement regarding said land; and

WHEREAS, the President and Board of Trustees of the Village of Orland Park find and believe it to be in the best interest of the Village that the land and territory be annexed to the Village;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Orland Park, Cook County, Illinois is as follows:

Section One: That all land and territory legally described as follows:

The South 5 acres of the North Half of the West Half of the Northeast Quarter of Section 29, Township 36 North, Range 12 East of the Third Principal Meridian in Cook County, Illinois.


