### THIRD AMENDMENT TO MORTGAGE

The Amended Note is secured by, among other things, that certain Mortgage dated May 30, 1985, recorded on June 11, 1985 with the Office of the Ricorder of Deeds of Cook County, Illinois as Document No. 85055135, as amended by that certain First Amendment to Mortgage dated July 30, 1985, recorded on August 21, 1985 with the Office of the Recorder of Deeds of Cook County, Illinois as Document No. 85155962 and that certain Second Amendment to Mortgage dated December 1 1985, recorded on January 8, 1986 with the Office of the Recorder of Deeds of Cook County, Illinois as Document No. 86008770, and covering the property described in Exhibit A to said Mortgage and Exhibit A-1 to said First Amendment (said Mortgage, as amended by said First Amendment and said Second Amendment, is hereit referred to as the "Mortgage").
- C. Mortgagor has requested and Mortgagee has agreed to extend the maturity date of the Amended Note from June 10, 1986 to December 31, 1986.

- 2. The Mortgage is hereby amended to secure the obligations and liabilities evidenced by the Amended Note.
- 3. All references to the Mortgage contained in the Amended Note, and all other documents and instruments securing the Amended Note, shall be deemed to refer to the Mortgage, as amended by this Third Amendment.
- 4. All references to the "Note" contained in the Mortgage shall be deemed to refer to the Amended Note.


