for and in said improvement, and that on May 28, 1986, the claimant completed thereunder all required by said contract to be done, including supplying materials to a value of \$9,129.78 plus \$1,098.34 previously paid by NSF check

That at the special instance and request of said contractor the claimant furnished extra and additional materials at and extra and additional labor on said premises of the value of \$ and completed same on 1986

That said owner, or the agent, architect or superintendent of owner (a) cannot, upon reasonable diligence, be found in said County, or (b) do not reside in said County.

That said contractor is entitled to credits on account thereof as follows:

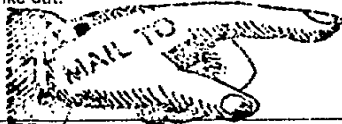
