MORTGAGE

THIS MORTGAGE made this 4th day of September, 1986, between DAVID M. BERTON, a bachelor, JOSEPH A. BERTON, a bachelor, and JAMES M. BERTON, a bachelor, as Joint Tenants, of 1104 N. Taylor, Oak Park, Illinois, 60302, (hereinafter referred to as "Mortgagor") and the RIVER FOREST STATE BANK AND TRUST COMPANY, (hereinafter referred to as "Mortgagee").

WHEREAS, Moregagor is indebted to Mortgagee in the principal sum of SEVENTY-SIX THOUSAND NINE HUNDRED FIFTY DOLLARS (\$76,950.00) which indebtedness is evidenced by Mortgagor's Note dated September 4, 1986, (herein referred to as the "Note"),

AND WHEREAS, the Note provides for interest to be charged on the balance of principal remaining from time to time outstanding at a rate equal to three percent (3.00%) above the weekly average yield, on United States Treasury Securities adjusted to a constant maturity of one year (hereinafter referred to is "Index"); and

WHEREAS, the initial interest rate charged under the Note for the first Twelve months is equal to eight and eighty-five one hund ediths percent (8.85%), which rate is equal to three percent (3.00%) above the most recently available Index and the interest rate charged under the terms of the Note is adjusted at intervals of twelve months during the term hereof;

WHEREAS, the Note provides for initial monthly installments of SIX HUNDRED THIRTY-THREE AND TWENTY-ONE ONE HUNDREDTHS DOLLARS (\$633.21) on the first day of each month commencing with October 1, 1986 with the balance of the indebtedness, if not sooner paid, due and payable on and September 1, 1996.



 - (b) Pay immediately when due and payable all general taxes, special taxes, special assessments, water charges, sewer service charges and other taxes and charges against the property, including those heretofore due, (the monthly payments provided in the Note in anticipation of such taxes and charges to be applied thereto provided said payments are a tuilly made under the terms of said Note), and to furnish the Mortgagee, upon request, with the original and duplicate receipts therefore, and all such items extended against said property shall be conclusively deemed valid for the purpose of this requirement.
 - Keep the improvements now existing or hereafter erected on the property Insured against loss or damage by fire, lightning, wind storm or such other hazards, as the Mortgagee may reasonably require to be insured against under policies providing for payment by the insurance companies or monies sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness secured hereby, in such companies through such agents of brokers and in such form as shall be satisfactory to the Mortgagee, until said indebtedness is fully paid, or in the case of foreclosure, until expiration of the period of redeription; such insurance policies, including additional and renewal policies shall be delivered to and kept by the Mortgagee and shall contain a clause satisfactory to the Mortgagee making them payable to the Mortgagee, as its interest may appear, and in case of loss under such policies, the Mortgagee is authorized to adjust, collect and compromise, in its discretion, all claims thereunder and the Mortgagor agrees to sign upon demand, all receipts, vouchers and releases required of him by the insurance companies; application by the Mortgagee of any of the proceeds of such insurance to the indebtedness hereby secured shall not excuse the Mortgagor from making all on monthly payments until the indebtedness is pald in full. - Not suffer or permit any unlawful use of or any nulsance to exist on said Premises nor to diminish nor impair its value by any act or omission to act.
- (g) Comply with all requirements of law or municipal ordinances with respect to the Premises and the use thereof.
- (h) Comply with the provisions of any lease if this Mortgage is on a leasehold.
- (i) Pay the premiums for any life, disability or other insurance if Mortgagor shall procure contracts of insurance upon his life and disability insurance making the Mortgagee assignee thereunder. The procurement of insurance or the payment of taxes or other liens or charges by Mortgagee shall not be a waiver of Mortgagee's right to accelerate the indebtedness secured by this Mortgage.
- 9. All remedies provided in this Mortgage are distinct and cumulative to any other right or remedy under this Mortgage or afforded by law or equity and may be exercised concurrently, independently or successively.
- 10. The covenants contained herein shall bind and the rights hereunder shall inure to, the respective successors and assigns of Mortgagee and Mortgagor subject to the provisions of paragraph 3 hereof. All covenants and agreements of Mortgagor shall be joint and several.
- Except to the extent any notice shall be required under applicable law to be given in another manner, any notice to Mortgagor shall be given by mailing such notice by certified mail addressed to Mortgagor at the property address or at such other address as Mortgagor may designate by notice to Mortgagee as provided herein and

- 13. Mortgagor hereby waives all right of homestead exemption in the Premises and grants to Mortgagee the right to inspect the Premises at all reasonable times and access thereto shall be permitted for that purpose.
- Mortgagor assigns to Mortgagee and authorizes the Mortgagee to negotiate for and collect any award for condemnation of all or any part of the Premises. The Mortgagee may, in its discretion, apply any such award to amounts due hereunder, or for restoration of the Premises.
- 15. It the Mortgagor is a corporation, the Mortgagor hereby waives any and all rights of redemption from sale under any order or decree of foreclosure of this Mortgage on its own behalf and on behalf of each and every person, except decree or judgment credities of the Mortgagor, acquiring any interest in or title to the Premises subsequent to the date of this Mortgage.
- This Mortgage shall be governed by the law of the jurisdiction in which the Premises are located. In the event one or more of the provisions contained in this Mortgage shall be provided or invalid under applicable law, such provision shall be ineffective only to the extent of such prohibition or invalidity, without invalidating the remainder of such provision or the remaining provisions of this Mortgage.
