SUBORDINATION AGREEMENT

THIS AGREEMENT by and between the BANK OF GLENBROK ("BANK") and ABRAHAM & GERTRUDE BLIT STEIN ("BLIT STEINS") is entered into by said parties for the purpose of determining the priority of certain mortgages affecting the real estate legally described as follows:

 - a) Trust Deed dated February 2, 1983, between HARLAN J. ROSEN and SANDRA M. ROSEN as Mortgagors, and Chicago Title & Trust Company, as Mortgagee, securing a note in the principal sum of \$50,000 (I.D. #687606). Said Trust Deed was recorded in the office of the Recorder of Deeds of Cook County, Illinois, on February 4, 1983, as Document No. 26496644.
