

That part of the West half of the Southwest quarter and of the West half of the Northwest quarter (taken as a tract) of Section 4, Township 42 North, Range 9, East of the Third Principal Meridian described as follows: Beginning on the East line of the West half of the Southwest quarter of said Section 4, 1667.90 feet (as measured along said East line) North of the South line of said Southwest quarter; thence West parallel with the South line of said Southwest quarter, 478.0 feet; thence North parallel with the West line of the Southwest quarter aforesaid a distance of 964.1 feet to the point of beginning of the tract of land herein described; continuing thence North parallel with the West line of the Southwest quarter aforesaid, a distance of 132.40 feet more or less to the center line on Donlea Road; thence Northeastly along the center line of Donlea Road, a distance of 8.891 feet more or less to the East line of the West half of the Northwest quarter of said Section 4; thence South along said East line a distance of 833.15 feet more or less to the South line of the West half of the Northwest quarter of said Section 4; thence South along the East line of the West half of the Southwest quarter of said Section 4, a distance of 4.6 feet to a point on said East line 2628 feet, as measured along said East line, North of the South line of said Southwest quarter; thence Southwesterly along a line bearing an angle with the East line of the West half of the Southwest quarter aforesaid of 69 degrees, 04 minutes, 05 seconds as measured from South to West, a distance of 268.05 feet; thence Northwesterly, 255.0 feet to the point of beginning in Cook County, Illinois***
