This cause coming on to be heard, the Court having jurisdiction of the parties and the subject matter, due notice having been given, and the Court having heard testimony and otherwise being fully advised in the premises:

THE COURT FINDS:

1. That on the premises commonly known as 01239 S KEDZIE Chicago, Illinois, there is a 0005 unit building.
2. That the legal description of said premises is \* LOT 136, SUB OF BLKS 1 TO 4 IN BALESTIER'S DOUGLAS PARK, ADD TO CHGO IN THE NW1/4 OF SECT 24 TWSP 39 NORTH, RANGE 13 EAST OF THE 3D PRINCIPAL MERIDIAN IN COOK COUNTY ILLINOIS PI# 16-24-100-018 *Oh.*
3. That by competent evidence, the Plaintiff has demonstrated that the subject premises fails to conform in all respects to the minimum standards of health and safety established by the Municipal Code of the City of Chicago, as set forth in Plaintiff's Complaint.

WHEREFORE, IT IS HEREBY ORDERED:

- B. That this Court shall retain jurisdiction of this matter for the purpose of enforcing the provisions of this Order.
- C. That this cause be and is hereby disposed subject to the permanent injunction aforesaid.

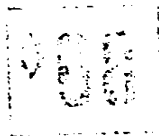


