THE COVENANTS CONDITIONS, PAUVISIONS AND ASSIGNMENT OF RENTE REFERRAL TO ON PAGE 1 (THE REVENUE SIDE

- 1. Mortgagor, shall keep the improvements on the Property Insured against any loss or damage occasioned by fire, extended coverage perils and such other hexards as Mortgages may require; through insurers approved by Mortgages, in amounts not less than the unpaid balance of the Indebtedness plus any other indebtedness secured by the Property, without co-insurance. The policies shall contain the standard mortgage clause in favor of Mortgages and, unless Mortgages otherwise agrees in writing, the original or, if this is not a first mortgage, a certificate or memorandum copy of all policies covering the Property shall be deposited with Mortgages. Mortgages and In promptly give notice of loss to insurance companies and Mortgages. If this is a first mortgage, Mortgages may adjust or compromise any claim and all proceeds from such insurance shall be applied, at Mortgages's option, to the installments of the Note in the inverse order of their maturities or to the restoration of the improvements on the Property.

Upon Mortgegor's failure to perform any duty, including without initiation paying any amount and the cost of such performance shall be due on demand and secured by this mortgege, bearing interest from date incurred until date paid at the lower of the annual percentage rate disclosed on the note of even date herewith or the highest rate allowed by law. No interest will be paid on funds held in Escrow and they may be commingled with Mortgegee's general funds.

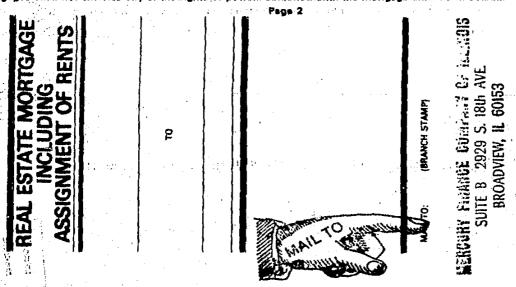

Although it is the intention of the parties that this assignment shall be a present assignment, it is expressly understood and agreed that Mortgages shall not exercise any of the rights or powers conferred until the mortgage shall be in default.
