

1. That the Judgment for Dissolution be modified and that the alimony payments of \$35.00 a week be and the same are hereby terminated and further that the Respondent shall pay to the Petitioner \$35.00 per week as and for child support on a temporary basis only until such time as the Respondent returns to active employment and that any subsequent order of support shall be entered retroactively to the date the Respondent begins his employment. The matter is set for further status report as to the Respondent's employment on May 10, 1993 at 9:30 a.m.

2. That the Respondent is found to be in arrears for maintenance child support and one-half of the cost of insurance in the amount of \$13,047.12 and that Judgment be and is hereby entered in favor of the Petitioner and against the Respondent for said amount and that this matter should likewise be continued to May 10, 1993 at 9:30 a.m. for the purposes of determining what method of payment on the arrearages will be made.
