6. The amount of cash contributed to the Partnership by the Limited Partner is as follows:



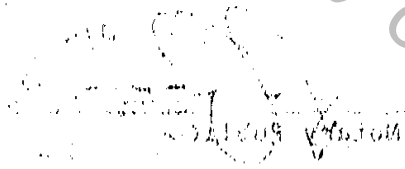
